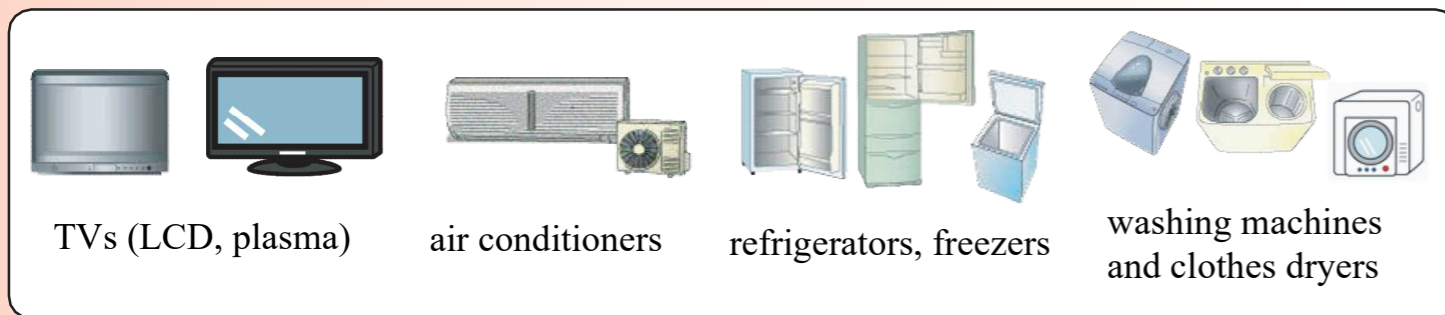


By virtue of the Act on Recycling of Specified Kinds of Home Appliances (Home Appliance Recycling Act), the recycling of four kinds of home appliances has been made compulsory. These will not be collected and disposed of by the city. Please ask the retailer to collect your used appliance or ask an electric appliance recycling company to collect it.

● Disposing of residential-use personal computers (includes displays)

By virtue of the Law for Promotion of Effective Utilization of Resources (PC recycling), personal computers (used or handmade) has to be collected by the manufacturer. These will not be collected and disposed of by the city. Please contact the manufacturer to collect your used personal computers.

Collection by individual manufacturers, etc.

 If a personal computer does not have a “PC recycle” sticker, you need to pay an additional recycling fee. Please contact the manufacturer of your PC or check the PC 3R Promotion Association homepage.

Collection by companies in the city

(Note) You will need to directly carry in your waste to such companies. Please contact them in advance to ask about how to carry in your waste and for any fees you will be charged.

Collection services provided by delivery companies

In accordance with the Small Home Appliance Recycling Act, companies that have been approved by the national government offer services that allow consumers to sign up over the Internet to have a delivery company visit their home on a specified date and time to collect such waste.



【 Steps 】

- (1) Place a request to Renet Japan Recycle, Inc. to collect your PC. URL <http://www.renet.jp/>
- (2) Package your PC in a cardboard box (the company will collect PCs that can fit in 1 cardboard box free-of-charge).
(Note) You may be charged a fee in certain cases.
 - The total length measured by adding up the height, width, and depth of the cardboard box must be 140 cm or less and its contents must weigh 20 kg or less.
(If you do not have a cardboard box, you can order one when placing your request [for an additional charge].)
- (3) Hand over your box to the delivery person who will visit you to collect your PC.
